

ANNUAL DEALER HUALER INSPECTION KINGDOM LIVESTOCK:

Originally scheduled for 8/5/2020 Ephraim canceled last minute that morning. Decided to give him allowance for one rescheduled appointment. He complied and we were able to keep our plans and inspection on 8/26/2020.

I, Jennifer Hartlieb PDA DAHI and Lu Ann Kubicar USDA AHT met with Samuel Stoltzfus, office manager Kingdom Livestock.

We conducted a thorough look at all of Kingdom Livestock's records for the past three months (June-August).

The records showing the destination and hauling were well kept however a significant issue on record keeping for the sources of the animals hauled was noted. I issued an NOV for inadequate record keeping.

In addition, it was noted that there was no record of animals hauled and sold to Centinar Farms in NJ. We were made aware of the Kingdom Livestock's business with Centinar Farms from the New Jersey Department of Agriculture. There was no file for Centinar Farms in the records Samuel provided.

We also had documentation provided from Molly Hankey, USDA AHT, that showed untagged animals from Kingdom Livestock that went through New Holland Sale. When asked why they were untagged Samuel didn't have an answer. We asked to see his record book for tagging anything that is untagged prior to moving them and he didn't have records.

I conducted a walk through of the property and barn area prior to Lu Ann arriving. It appeared that at the time of inspection their compost pile was sufficiently covered and that dead animals were disposed of correctly.

I did note on a barn walk through a pen of adult billy goats (approximately 120) that were all not tagged. Samuel responded when questioned that they are too wild to get a hold of and even loading is an issue. They came from Texas . Please refer to picture 1 and picture 2.
